Spiritual Identity and the Function of Religion in the Short Stories of Ioan Popovici

Abstract:

In the context where Ioan Popovici's short stories was most often associated with the social theme of provincial town life, we consider that an interrogation of it through the lens of some symbolic spatial figures present in his texts could represent a contribution to the renewal of geocritical approaches of our short prose, at least insofar as that these spatial figures involve a series of symbolic and linguistic representations generating new paradigms of meaning. In this context, the hypothesis underlying the present approach is that in Ioan Popovici's short prose the appeal to Christian morality could be interpreted as the result of an existential and/or identity aporia, in full congruence with the very idea of nation. To this end, this article aims to answer two questions: How does the identity validation of the characters function within the narrative discourse proposed by Ioan Popovici? To what extent does this approach/rejection of spirituality become the main attitude through which the characters can reflect on their own identity?

The Reichenau Glosses and Romanian Language

Abstract:

Classical Latin has, for different meanings, pairs of synonyms or multiple synonyms.

Proto-Romance, the unattested language from which all Romance languages come, has abandoned some of these synonyms and kept others. The Romance vocabulary means selection, lexical replacement and semantic change of Latin words. We show in the article that, for most meanings, Romanian keeps the same synonyms that are kept in the other Romance languages, and loses the synonyms that are lost in the other Romance languages. We have no direct access to the proto-Romance spoken anywhere between 700-800. But the *Reichenau Glosses* are a collection of Latin glosses written after 700 in northern France. Their Latin explanations are classicizing forms of the Romance language spoken around 700; they offer us an indirect glimpse on the spoken language of the time. More often than by mere chance, they correspond to the Romanian words of Latin origin, which proves that they come from a Late Latin language that had already lost some synonyms and kept another set.

Furthermore, we show that Romanian keeps some words that are lost in French, and therefore proto-Romanian was probably separated earlier from the common proto-Romance than proto-French. We propose a few language evolution models, fast and slow, and try to calculate the period when proto-Romanian split, based on rough lexicostatistical and glottochronological estimations. The data

suggest the period between the years $540-600 \pm 30$ as the period when proto-Romanian split from the undifferentiated proto-Romance.
